Council Member Clark motioned to hold the Truth-in-Taxation Hearing on December 1, 2025, at 7 pm. Council Member Hunt seconded the motion. Mayor Lindstrand called for a voice vote: Clark - Yes, Hunt - Yes, and McGillivray - Yes. Motion carried with Council Member Giese absent.

### **NEW BUSINESS**

**Resolution 202517:** Council Member Hunt motioned to approve Resolution 202517 A Resolution to Establish a New Municipal Checking Account and Designate Authorized Signatories. Council Member Clark seconded the motion. Mayor Lindstrand called for a voice vote: Clark - Yes, Hunt - Yes, and McGillivray - Yes. Motion carried with Council Member Giese absent.

**Moore Engineering/USDA RD Update:** Kevin Freisen from USDA Rural Development was present with Moore Engineering to discuss a \$510,000 funding shortfall for project contingencies due to the Water Tower bid coming in higher than estimated. Jon Pauna from Moore Engineering recommended moving the alternate for boring an additional line under Highway 12 to Phase 2 or 3 of the Preliminary Engineering Report planned phases, which would reduce the contingency shortfall by \$254,471. He further recommended using on-hand reserve funds for the remaining contingency shortfall of \$255,529 so the project can continue moving forward with awarding the Contract A bid.

Council Member Hunt motioned to approve Resolution 202519, a resolution authorizing the application for additional funding from USDA Rural Development. This resolution allows the City to apply for additional funding if needed to cover the contingency shortfall. Council Member Clark seconded the motion. Mayor Lindstrand called for a voice vote: Clark – Yes, Hunt – Yes, McGillivray – Yes. Motion carried with Council Member Giese absent.

Additional soil borings will be completed in preparation for construction of the water tower foundation, which is scheduled to begin on October 6th.

**Resolution 202518:** Council Member Hunt motioned to approve Resolution 202518 A Resolution Authorizing Execution of an Advance Agreement and Participation In Joint Powers Authority for a Water Project for the City of Kandiyohi, Minnesota and Accepting the Offer of the Minnesota Rural Water Finance Authority to Purchase a \$1,079,000 General Obligation Utility Revenue Bond Anticipation Note of 2025A and Providing for its Issuance. Council Member McGillivray seconded the motion. Mayor Lindstrand called for a voice vote: Clark – Yes, Hunt – Yes, McGillivray – Yes. Motion carried with Council Member Giese absent.
